The Institute's residential block, office and hostel building is situated inside the NCERT Campus, 17-B, Sri Aurobindo Marg, New Delhi-110016. The Institute invites quotations from interested parties to enter into an Annual Contract for Disinfection and Cleaning of Water Tanks in its premises. 2. The participating bidders shall enclose their company literature, relevant registration certificate and list of offices where similar kind of services have been provided in the last 3 years. The bidders may also provide details of facility for mechanized cleaning available.

3. The contract will be valid for a period of one year, which may be extended further on year to year basis upto a period of 3 years on the same rates and terms and conditions.

4. The scope of work shall include disinfecting, cleaning, removal of dirt, fungus and stains, scrubbing, sludge removal and other cleaning work wherever required. The process/method of cleaning to be adopted or proposed to be followed be elaborated in your proposal. You will be required to take signatures from respective users/authorized officials of NIEPA after cleaning of

water tanks.

5. The cleaning of water tanks will, generally, has to be done quarterly under the supervision of the Caretaker of the Institute. If required, the Institute may also ask to provide additional visits

during the contract period for cleaning of any or all of the water tanks.

6. After award of contract, the successful firm will have to deposit a sum equivalent to 10% of the total contract value as Security Deposit. In case of poor services the security deposit will be

forfeited.

7. Payment will be made quarterly after due certification of the services provided during the

respective quarter. No part or advance payment shall be made during the contract.

8. The service provider shall be responsible for following up of Guidelines and safety standards issued by World Health Organization or other relevant authorities while cleaning water tanks. Safety of the deployed manpower shall be the responsibility of the service

provider.

9. The Institute may, at its discretion, extend the deadline for submission of proposals or cancel the requirement in part or in whole. The Institute reserves the right to reject any

or all proposals without assigning any reason thereof.
